**TEMPORARY RESIDENT  
(DEPENDANT OF A FOREIGN WHO IS A HOLDER OF A  
TEMPORARY/PERMANENT RESIDENT VISA OR TEMPORARY CARD OF MEXICO)**

**REQUIREMENTS:**

1. **Visa Application.** Must be written in [English](#) or [Spanish](#) and signed the same as the signature in the passport. [Download here in English or Spanish](#)
2. **Valid passport original and one photocopy of the main page**  
6 months validity rule
3. **One passport size color picture**  
Front view, no eyeglasses and white background.
4. **Original and one photocopy of the Alien Registrarion Card (ARC)**  
Or the document that proves the applicant is a foreign legal resident of South Korea. This only applies for non-Korean citizens.
5. **Visa fee around 70,000 KRW (depending on the USD/KRW exchange rate)**  
We only accept cash KOREAN WON to be paid after the visa interview. We do not accept credit/debit cards. Non-refundable if not approved.
6. **Original and copy of the document that shows the family relationship with the holder of the temporary/permanent resident visa or temporary/permanent resident card of Mexico:**
  - **Spouse:** original and copy of the marriage certificate.
  - **Parent:** original birth certificate of the applicant (the visa will only be granted if the applicant is under 18 years of age, and he/she has not contracted marriage or is in a state of interdiction and is under his/her legal guardianship).
  - **Child:** original birth certificate of the child.
7. **Original and copy of the valid temporary/permanent resident visa or temporary/permanent resident card of Mexico**  
The applicant's family member who is the holder of the temporary/permanent resident visa or card of Mexico must be present at time of application)
8. **Proof of economic solvency (only applies if the applicant family member is a holder of a temporary/permanent resident visa of Mexico):**
  - a) Original and copy of the proof of personal investments accounts or personal bank accounts with a monthly balance of at least **\$1,203,359 KRW** after taxes during the previous 12 months of statements (bring the last 12 months of bank statements) 은행 거래 내역서 (입금 내역만)
  - b) Original and copy of documents showing that the applicant has a job or pension that yields a monthly income of **\$1,203,359 KRW** after taxes during the **previous 7 months**. (Bring the last 7 months of your paystubs and the bank statements that shows the direct deposit of your salary.) 은행 거래 내역서 (입금 내역만)

\*All bank statements must be original.

\*If you use paperless banking, you must have your statements stamped by your bank. We do not accept simple prints from downloaded bank statements.

\*The Documents must be in English or Spanish.

\*If the applicant is a minor, both parents should be present to sign the application. If only one parent is present, it is mandatory to submit a notarized authorization (Spanish or English) from the other parent. If minors or persons requiring legal guardianship attend by themselves or someone different to their parents, it is mandatory to submit a notarized document in which their parents or legal guardianship authorize the visa application.

**After entering Mexico with this kind of visa you have 30 days to go to the nearest "INSTITUTO NACIONAL DE MIGRACIÓN" (INAMI) office to get your resident ID.**

**IMPORTANT NOTES:**

1. To apply for a visit first you will need an appointment at the booking page: <https:// citas.sre.gob.mx/>

2. The issuance of visa might take up to 10 working days after the interview day. If necessary, you might be asked to support your application with supplementary documentation.

**TEMPORARY RESIDENT**  
**(DEPENDANT OF A FOREIGN WHO IS A HOLDER OF A**  
**TEMPORARY/PERMANENT RESIDENT VISA OR TEMPORARY CARD OF MEXICO)**

3. In the case of a spouse, parent or child who is economically dependent upon the foreigner holding the Mexican visa, the person may simply prove the family relationship with official documents (original) and prove economic solvency per each relative.
4. If you present a document issued from a country different than Mexico or South Korea, it must come with an apostille or legalization as applicable, and with an official translation to Spanish, this applies also for the bank statement.
