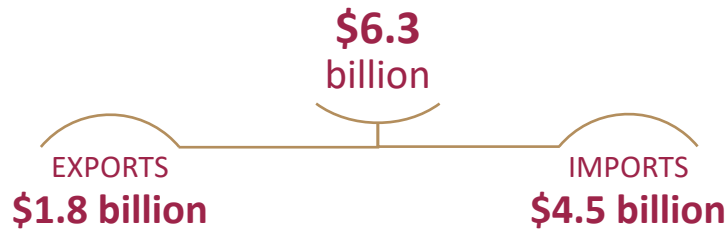




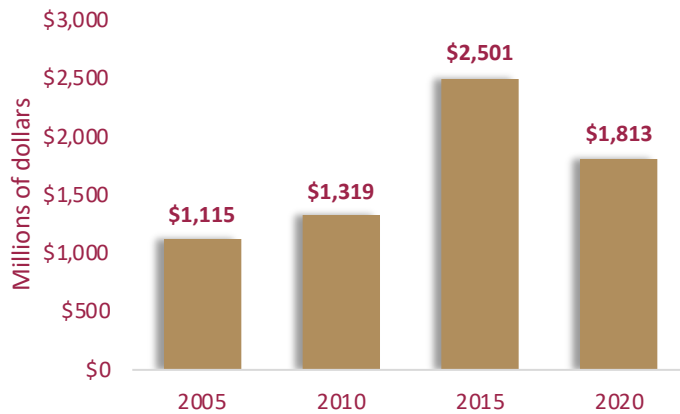
## TOTAL TRADE WITH MEXICO IN 2020<sup>1</sup>



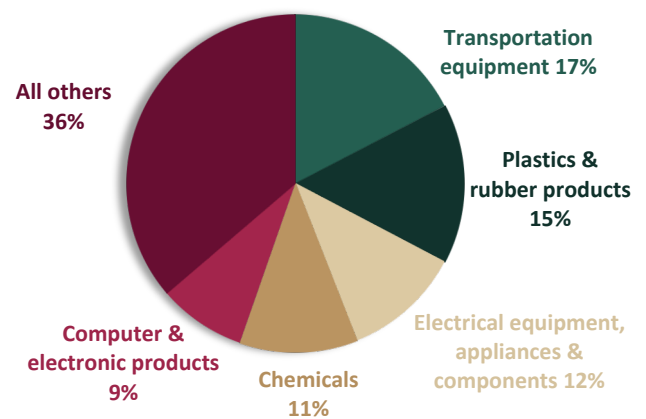
South Carolina's exports to Mexico exceed the exports of the United States to Portugal.

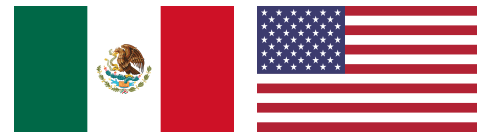

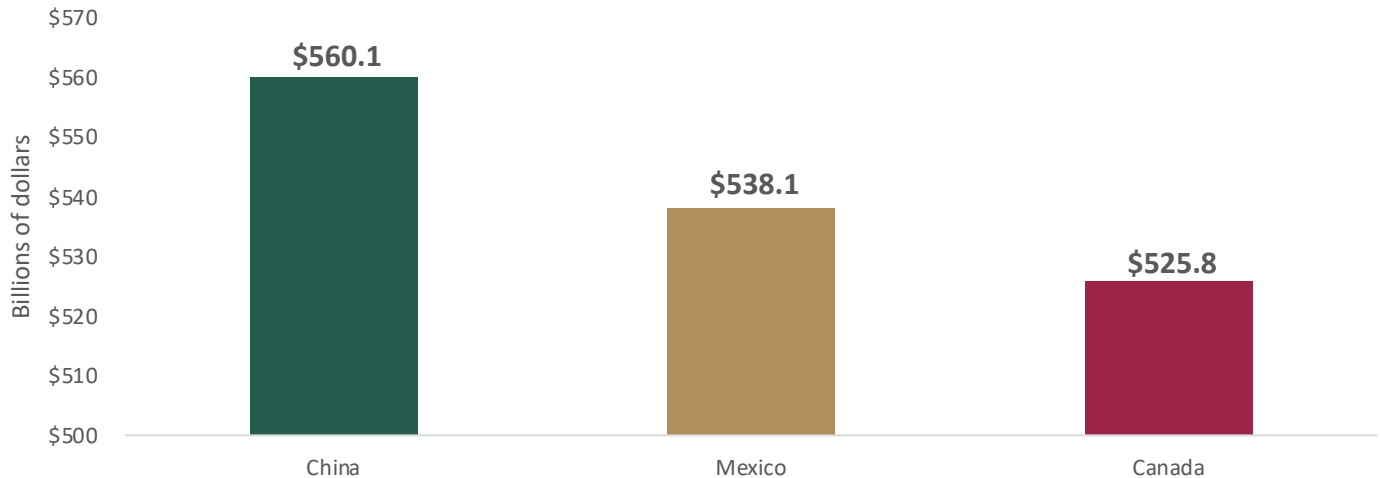

## MEXICO WAS THE UNITED STATES' #2 TRADING PARTNER IN 2020<sup>1</sup>



### U.S. – Mexico Trade



**Jobs:** Trade with Mexico supports 5 million American jobs throughout the nation, which equals 12.2% of all trade-related jobs in the U.S.<sup>2</sup>



**Exports:** In 2020, Mexico was one of the top three merchandise export markets for 29 U.S. states.<sup>1</sup>



**Total Trade:** Trade with Mexico reached \$538.1 billion in 2020, which equals about 14.3% of all U.S. exports.<sup>1</sup>



**U.S. Manufacturers:** U.S.-manufactured goods trade with Mexico supports the jobs of more than 147 thousand men and women across the United States.<sup>2</sup> Mexico is one of the top three purchasers of manufacturing exports for 32 U.S. states.<sup>1</sup>



**Essential for Farmers and Ranchers:** U.S. agricultural exports to Mexico have increased 5x since the implementation of NAFTA, from \$3.6 billion in 1993 to \$18 billion in 2020. Mexico purchased 12.4% of all U.S. agricultural exports in 2020.<sup>3</sup>



**Powers the Service Economy:** U.S. services exports to Mexico have exponentially grown 217% since NAFTA's implementation, from \$10.3 billion in 1993 to \$32.9 billion in 2019.<sup>4</sup> U.S. service exports supports over 4.5 million U.S. jobs.<sup>2</sup>
