IV. Minors

In the case of children, adolescents or persons who are subject to legal protection under civil law, they must present the visa application signed by the mother and father, or by those exercising parental authority or guardianship. If the request is submitted by one of the parents, they must submit a notarized authorization from the other parent who authorizes the visa process.

When they go alone or with a third party of legal age, they must present a document issued before a notary public or by an authority that has the power to do so, in which the authorization of both parents or of those who exercise parental authority or guardianship is recorded. In the case of minors, the signature will be of the parents or guardians, or those who exercise parental authority.

In cases where the applicant presents altered, apocryphal, or fraudulently obtained documents, it will be registered in the migratory control lists and will not be able to obtain a visa to enter Mexico.

According to the Law and its Regulations, the Mexican visa allows the foreign person to appear at a place destined to the international transit of persons and in the filter of migratory revision and request their entry into national territory. The presentation of a visa does not guarantee entry into national territory. Admission to Mexico is subject to the approval of the sanitary and migratory authorities at the point of entry, which may verify at all times the requirements established in the legal provisions applicable in the migration review filter.
