About Temporary Resident Visa

Q1. My husband is going to work in Mexico and he already has a residence card. How can his family get the visa?

A: If you are Japanese national or other national who does not require Mexican visa to enter the country, you can enter and stay in Mexico for up to 180 days without any visa. During your stay, you can change your migratory status to temporary family unit residence. You need to follow the procedures of the Immigration Bureau in Mexico. Q2. After I get a Mexican residence card, how long can I stay in Mexico?

A: In the case that you have a Mexican temporary residence Visa, you can stay in Mexico from 180 days up to 4 years. For more information about the renovation of your visa, please refer to the following link: <http://www.inm.gob.mx>

About Temporary Resident Visa with permission to conduct remunerated activities

Q3. I have already applied for permission at the Mexican Immigration but I have not got any notice or document yet.

About Visitor Visa

Q5. I am a foreign national with a legal resident status in Japan and I would like to know if I need to apply for a Mexican Visa.

A: If your nationality is not listed below and your Japanese residence card is the only document which you have, then you need to apply for a Mexican visa.

*In case you wish to visit Mexico as tourists, in transit, for business, technical activities, studies, etc, for a period not exceeding 180 days, and will not receive any remuneration at all in Mexican territory.
