VISA- Visitor or temporary resident with permission to engage in gainful activity

Foreigners who wish to travel to Mexico with the intent to conduct remunerated activities must have an offer of employment. The Mexican institution, company or person who intends to hire the foreigner must submit the **visa application directly to the National Migration Institute (Instituto Nacional de Migración, INM) in Mexico**. The Embassy or Consulate may only issue a visa if it has been authorized by the **INM**.


