Temporary Resident visa - Student

Embassy of Mexico to Czech Republic

Applicable to foreigners who wish to enter Mexico with an immigration status as a temporary resident to study for more than 180 days but not exceeding four years.

Applications are received with prior appointment. To request an appointment, Email: embamexche.consulado@sre.qob.mx

All applicants must appear in person for an interview, including minors, who must be accompanied by mother and father or legal guardians. **Kindly notice:** the period for processing a visa application is of a maximum of 10 working days.

Requirements:

- I. Fill out an application form. Applications can be obtained at the Consular Section.
- II. Valid Passport + 1 photocopy (the page where picture and signature is).
- III. One passport size front color picture, without glasses, white background.
- IV. Proof of your legal status in Czech Republic + 1 photocopy:
- V. Present the following documents:
 - 1. Original + copy of acceptance letter from an institution belonging to the National Educational System in Mexico, which specifies:
 - i. Full name of applicant;
 - ii. Level, degree and area of study that the applicant proposes to carry;
 - iii. Name of the course the applicant has been accepted to;
 - iv. Starting date and completion of the course (complete career);
 - v. Tuition fee, and
 - vi. Registration number of the Institution.
 - 2. Sufficient funds to cover tuition, boarding and food expenses during his/her stay in Mexico, through:
 - 1. Original and copies of documents proving that the person has an employment with a monthly income, pension or scholarship of more than the equivalent of 100 days of minimum wage in Mexico City, during the last three months. **OR**
 - 2. Original and copy of Bank account with a monthly balance of at least the equivalent of 1000 days of minimum wage in Mexico City*, during the last 3 months. (Bank letter and statements of the last three months).

Documents not issued by Mexican or Czech authorities must be legalized or apostilled.

In the case of students less than 25 years, the economic solvency can be proven by one of the parents or the person who has full custody or guardianship of the applicant. The following documents should be presented:

- Birth certificate of the student or document proving the family relationship with the parent, or court decision establishing the authority, custody or guardianship.
- If the birth certificate or court order is not from Czech Republic, the document must be apostilled or legalized and translated into Spanish, except those which are in English.
- Original and copy of the identification of the parent(s) or guardian(s) proving the economic solvency (passport,).

The economic solvency can also be accredited by original letter from the institution confirming that he has been a recipient of a scholarship or original document from a bank or financial institution certifying that he has received funding.

V. Payment of the visa fee (\$ 48.00 us dollars). No other currency is accepted. Please notice that there is no reimbursement for visa payment, even if the visa is denied. The payment is for the review of your application, so please check carefully that you have the completed documents before submitting your application.

Presentation of these documents does not guarantee visa issuance. Please kindly notice that all applications are subject to approval. A visa does not guarantee entry into Mexico, where the final decision will be taken by an immigration officer at the point of entry.

The holder of a Temporary Resident Student Visa must visit the nearest immigration office within the next 30 days after entering Mexican territory, to process their Residency card which authorizes their legal stay in national territory.
